These Terms and Conditions govern the Exaforce, Inc. Oura Ring Promotional Gift (the “Offer”) made available at Black Hat USA 2026. By attending a Demonstration Session and accepting the Gift or electing the Donation Alternative, you confirm that you have read, understood, and agree to be bound by these Terms and Conditions in full.

1. Definitions

The following terms have the meanings set out below wherever they appear in these Terms and Conditions.

Term	Meaning
"Exaforce"	Exaforce, Inc., a Delaware corporation.
"Offer"	This promotional gift program under which a qualifying Recipient may receive the Gift or elect the Donation Alternative, as described in these Terms and Conditions.
"Recipient"	An individual who has been personally invited by Exaforce, has met all eligibility requirements under Section 3, and has attended and completed a Demonstration Session.
"Gift"	One (1) Oura Ring Gen 3 smart health ring, valued at approximately \$299–\$499 USD at retail, provided in the size confirmed by the Recipient prior to the Demonstration Session.
"Demonstration Session"	A private, in-person, 30-minute product demonstration of the Exaforce platform conducted at Booth 4144, Black Hat USA 2026.
"Donation Alternative"	An option available to Recipients who are unable to accept the Gift due to their employer’s gift acceptance policy, under which Exaforce will make a charitable donation of \$250 USD on behalf of the Recipient to an organization selected from the approved list in Section 7.
"Company Policy"	The Recipient’s employer’s applicable policies governing the acceptance of gifts, hospitality, or items of value from vendors or third parties.

2. Offer Overview

Exaforce is making this Offer available at Black Hat USA 2026 as a promotional initiative. The Offer is subject to the following conditions:

- a. The Offer is available only to individuals who have been personally and individually invited by an authorized Exaforce representative.
- b. Invitation does not guarantee eligibility. Exaforce reserves the right to confirm or deny eligibility for any individual at its sole discretion.
- c. The Offer is available only during Black Hat USA 2026 (August 1–6, 2026) at Mandalay Bay Resort, Las Vegas, Nevada.
- d. Completion of a full Demonstration Session is a mandatory condition of receiving the Gift or the Donation Alternative. No alternative means of qualification is available.

- e. The Offer is limited to one (1) Gift or one (1) Donation Alternative per Recipient. It is non-transferable and has no cash value.
- f. The total number of Gifts available is limited. Exaforce reserves the right to close the Offer once available inventory is exhausted.

3. Eligibility

To be eligible to receive the Gift or Donation Alternative, an individual must meet all of the following requirements:

- g. Be 18 years of age or older at the time of the Demonstration Session.
- h. Be a registered attendee of Black Hat USA 2026.
- i. Have been personally invited by an authorized Exaforce representative.
- j. Have been confirmed by Exaforce as meeting its internal customer profile criteria, which include but are not limited to: seniority in a security operations, security engineering, or technology leadership role; employment at a company within Exaforce's target market; and decision-making authority or direct influence over security technology purchases.
- k. Have confirmed attendance and ring size (if applicable) in advance of the Demonstration Session.
- l. Have attended and completed the full 30-minute Demonstration Session.

The following individuals are not eligible:

- a. Employees, officers, directors, agents, or representatives of Exaforce or any of its affiliates.
- b. Individuals who are not registered attendees of Black Hat USA 2026.
- c. Individuals who have previously received a Gift under this Offer at a prior event.
- d. Any individual whose participation in the Offer would violate applicable law or regulation.

4. Gift Acceptance and Company Policy Compliance

Recipients may be subject to their employer's Company Policy governing the acceptance of gifts from vendors. It is the sole and exclusive responsibility of each Recipient to:

5. Donation Alternative

Recipients who are unable to accept the Gift due to their Company Policy may elect the Donation Alternative. Under the Donation Alternative:

- a. Exaforce will make a charitable donation of \$250 USD on behalf of the Recipient to a trauma center selected by the Recipient from the approved list set out in Section 7.
- b. The donation will be made in such manner as Exaforce determines is appropriate, subject to the policies of the receiving organization.
- c. Exaforce will provide the Recipient with written confirmation of the donation within 30 business days of the Demonstration Session.
- d. The Donation Alternative has no cash value to the Recipient. Any tax documentation will be issued to Exaforce as the donor of record. No tax receipt or charitable acknowledgment letter will be issued to the Recipient.
- e. The Donation Alternative is non-transferable and may not be redirected to any organization other than those listed in Section 7.
- f. The Donation Alternative must be elected at or before the time of the Demonstration Session. It may not be elected retroactively after the Gift has been provided to the Recipient.

Exaforce reserves the right to modify the donation amount or the list of approved organizations at any time prior to the Demonstration Session. Any such modification will be communicated to confirmed Recipients in advance.

- b. Any warranty claims relating to the Oura Ring Gen 3 must be directed to Oura Health Oy or its authorized representatives in accordance with the manufacturer's warranty terms. Exaforce has no responsibility for the performance, functionality, or durability of the Gift.
- c. Exaforce is not responsible for any damage, loss, or injury arising from the use or misuse of the Gift.
- d. Exaforce reserves the right to substitute the Gift with an item of equal or greater retail value if the Oura Ring Gen 3 is unavailable in the required size or for any other operational reason.
- e. Exaforce reserves the right to cancel, modify, or terminate the Offer at any time without prior notice, subject to honoring commitments already confirmed in writing to individual Recipients.
- f. In no event shall Exaforce's aggregate liability to any Recipient in connection with this Offer exceed the retail value of one (1) Oura Ring Gen 3.
